In pursuance of Section 108 of the Companies Act, 2013 read with rule 20 of the Companies (Management and Administration) Rules, 2014 as amended and Regulation of the SEBI (LODR), Regulation 2015, the Company is providing e-voting facility to its Members as provided by NSDL on all resolutions as set out in the Notice of 41st AGM. Members of the Company may transact the business through voting by electronic means.

1. The remote e-voting facility commences on **Tuesday 18.08.2026 (9:00 AM)** and ends on **Thursday 20.08.2026 (5:00 PM)**. For all shareholders, whether holding shares in physical form or in dematerialized form, the e-voting module shall be deployed by NSDL for Voting. Remote e-voting shall not be allowed beyond the said date and time.

2. The cut-off date to determine eligibility to cast votes by electronic Voting is **Friday, 14th August, 2026**.
